Dear Sirs:

We are extremely concerned about the continuing level of violence in Guatemala. In recent weeks at least four Guatemalan politicians have been murdered: **Christian Humberto Gómez Sánchez**, Secretary of Youth for the Patriot Party in Izabal; **Eleazer Tebalán**, Coordinator of the Encounter for Guatemala Party in Coatepeque, Quetzaltenango; **Mario Pivaral**, National Unity of Hope Representative; and **Attorney Rodolfo Vielman**, who worked with the Patriot Party. These are more than merely names. They are people who should have been able to freely express their political views without fear of reprisal.

We are also aware of the brutal murder of **Meregilda Súchite**, a mother of eight children, midwife, community leader, and active member of the Network of Women Observers of Human Rights, which is promoted by the Center for Human Rights Legal Action (CALDH) in the Ch'orti' region of Chiquimula Department. Meregilda and her husband Longio Díaz were on their way to Mass at the community church in Tuticopote Abajo, Olopa, Chiquimula Department on April 2. A gunman opened fire, shot Sra. Suchite six times and then killed her by stabbing her in the eyes, mouth and chest with a machete.

It appears that her murder was meant to intimidate those working for justice and human rights in the area. The murder suspect is César Pérez González, a worker in the Integral Security Service (SIS) that provides security for the Banrural de Esquipulas. He has not been arrested. He is armed and is threatening to kill another member of the Diaz Súchite family.

In light of these facts, we strongly urge you to

- investigate the murders of the four politicians named above, make the results public and bring those responsible to justice
- thoroughly and immediately investigate the murder of Meregilda Súchite, arrest the suspect, bring him to justice and ensure that he does not inflict further harm on the family;
- guarantee the safely of all human rights monitors and defenders in Guatemala;
- ensure that all people in Guatemala have the right to express their political opinions freely and without fear of reprisal.

As a consequence of your high position in Guatemala, you have the authority and the responsibility to take these actions. Be assured that we will make sure that our elected officials here in the United States are made aware of human rights violations in Guatemala.
