Dear Sirs:

We are concerned for the safety of **Angel Mario Ksheratto Flores**, a journalist from Chiapas State, who was re-arrested on February 4 for breaking bail conditions imposed after he was charged with defamation in 2003. He is being detained in El Amate, Chiapas.

Ksheratto works for the newspaper Cuarto Poder. He was first detained on January 9, 2003 by the Chiapas State Prosecutor's Office, following a defamation complaint. A senior state official complained about articles in which Ksheratto alleged official corruption by a member of the state-run Schools Construction Committee. After his release on bail, Ksheratto did not comply with the condition of reporting to court every week because the court office moved from his city of Tuxtla Gutierrez to El Amate, which is 90km away. He was denied a petition to report every two weeks.

According to reports, a local judge is considering imposing bail of US\$20,000. This amount would constitute a disproportionate obstacle to pre-trial liberty for a non-serious offense. This raises serious concern about whether the court is sufficiently independent and impartial to meet international standards for fair trial. We believe that Ksheratto's re-arrest may constitute judicial harassment, and that his case fits a pattern of intimidation of journalists with the intention of restricting freedom of expression.

We urge you to:

- > guarantee the prompt and impartial application of international human rights standards to ensure Angel Mario Ksheratto receives a fair trial:
- implement the Inter-American Commission on Human Rights' recommendation to make defamation and liable civil offences not liable to imprisonment.
