Dear Sirs:

We are <u>extremely</u> concerned for the safety of employees of the Team for Community Studies and Psychosocial Action (ECAP) in Rabinal, Baja Verapaz Department, who have been the victims of threats and intimidation on two occasions in the past two months. On the morning of September 30 an employee of ECAP was followed for several hours in Rabinal by an Isuzu car with tinted windows and without license plates. On October 2 at approximately 3:00 AM, a letter was found at the ECAP office in Rabinal that said, "You should be careful, because you all are scheduled for a kidnapping and for something more...This October 2 you shouldn't travel at all or meet with anyone...Take care of yourselves before you regret it..."

ECAP's work with human rights victims has made ECAP workers the targets of intimidation. ECAP accompanies exhumations and provides psychosocial support to survivors of the massacre in Plan de Sánchez, near Rabinal, on July 18, 1982. The massacre of 250 villagers was part of the "scorched earth" policy of then-President (General) Efraín Ríos Montt. ECAP also tracks the reparations process for the survivors and families of the massacre victims.

In light of these facts, we strongly urge you to

- investigate the threats against ECAP and hold those responsible accountable;
- provide adequate security for ECAP employees
- stop threats and intimidation against ECAP employees

We remind you that failing to protect human rights workers and investigate attacks or threats against them is a violation of the 1996 Peace Accords. Under the Accords, the government of Guatemala agreed to "take special measures to protect those persons or entities working in the field of human rights," and to "investigate, in a timely and exhaustive manner, any complaint it may receive relating to acts or threats that may be directed at them." We strongly urge you to follow through on your commitment.
