Dear Sirs:

We are horrified to learn of the assassinations on January 9 of **Wilber Moises Funes**, mayor of Alegría municipality, Usulután Deartment, and of **Zulma Rivera**, a 22-year old municipal worker in charge of contracts and purchasing, who were shot and killed while riding in an official vehicle. They were traveling to a site to supervise the construction of a sports facility in the Las Casistas area of the municipality when unknown assailants intercepted them and opened fire. Rivera was killed immediately, while Funes died in transit to a hospital in Santiago de Maria.

Wilber Moises Funes, 33, one of the youngest mayors in the country, took office in May 2006 and was a member of the FMLN, El Salvador's main opposition party. He was dedicated to creating projects for the benefit of the poorest communities in his area while defending the interest of public services still owned by the municipality. Prior to his election in 2006, the preceding municipal administration of the ARENA party handed over the Laguna Alegría Natural Park to a community development association called ADESCAM. The privatization of this valuable resource was part of a broader ARENA strategy to leave newly-elected FMLN municipal governments without the resources to function.

Prior to his assassination, Funes had been threatened and harassed.

We **strongly urge** that you authorize an immediate, independent, and objective investigation into the assassinations of Wilber Moises Funes and Zulma Rivera, make the results public and bring those responsible to justice.
