Dear Sirs:

We are concerned for the safety of indigenous communities in Ocotlán Valley and for members of CODEP-APPO (Committee in Defense of the Rights of the People-Popular Assembly of the People of Oaxaca) and their taxi service that provides transport between communities, particularly after the assassination of taxi driver and CODEP leader Sergio Martínez Vásquez and the beating of Agustin Ríos Cruz.

In order to protect their air, water, soil and human health, indigenous communities in Ocotlán Valley have been demanding the closure of mines operated by Canadian-owned corporation Fortuna Silver. Tests carried out by independent laboratory Sanica have confirmed the presence of arsenic, cyanide, lead and mercury stemming from mining activities. Local newspaper *El Imparcial* reported that government officials were being paid by the company to maintain their support for the mining project and that the company has armed paramilitary groups to intimidate people who oppose them. Paramilitary forces have been used by the government of Oaxaca to repress demonstrations by APPO and other popular social movements since 2006.

On June 7, Sergio Martínez Vásquez, a member of CODEP's state council, was shot dead; paramilitaries are suspected as the perpetrators. Odontologist Agustin Ríos Cruz, another CODEP member, was recently beaten almost to death. Repression against members of popular social movements since 2006 has included assassinations (notably, US journalist Brad Will), raids and imprisonment. Some, including Agustin Ríos Cruz, have been forced into exile.

Because of the incidents mentioned above, we urgently demand:

- an immediate public investigation into the murder of Sergio Martínez Vásquez and the assault on Agustin Ríos Cruz, make the results public and bring the perpetrators to justice;
- an end to the violation of human rights of the indigenous people of Ocotlán, the members of CODEP and its taxi service, and the teachers who support them;
- the departure of mining companies that have been contaminating water and soil in the Ocotlán. Valley.
