Dear Sirs:

We, members of the InterReligious Task Force, are concerned about the safety of **Adolfo Guzman Ordaz**, an indigenous rights activist who works for Communication and Training Link, and his wife **Margarita Martínez**. On February 25, 2010, Margarita Martínez, was abducted, beaten and threatened. She was on the way to collect her son from school in the Chiapas town of San Cristobal de las Casas when she was abducted by a group of at least two men. They placed a plastic bag over her head, forced her into a car, hit her in the face with a blunt instrument, and poked her in the ribs with what felt like a gun. Her abductors told her, "You won't be able to work any more." They also threatened her with death and told her to drop the complaint that she and her husband had filed in November after state judicial police officers raided their home in Comitan without showing a warrant. Before letting her go they told her, "This is a little present from the Mayor of Comitan."

Margarita Martínez and Adolfo Guzman's home was raided by state police on November 8. About 20 state judicial police officers (Policia Ministerial) came in without showing a warrant, intimidated Adolfo Guzman and pointed a gun at Margarita Martinez. The police said they were looking for "someone," without saying who this was.

This is our second letter to Mexican officials in a month. We wrote to you February 11 urging protection for Adolfo Guzman and his family because of the threats made in December and January after the state police raid on November 8.

Because of the recent attack on Margarita Martínez, we strongly urge you to

- provide immediate and effective protection for Adolfo Guzman and his family, in accordance with their wishes;
- conduct a prompt and impartial investigation into the abduction, beating and threats received by Margarita Martinez, , make the results public and bring those responsible to justice.
