Dear Sirs:

We, members of the InterReligious Taskforce on Central America, are extremely concerned for the safety of community activist **Margarita Guadalupe Martínez**. On November 24, as she left a café in San Cristobal de la Casas, she was approached by three men, two on foot and one in a pick-up truck, and told "do as we tell you; otherwise we'll shoot you." She was given a letter addressed to 'Diego,' the head of Fray Bartolome de las Casas Human Rights Center, a local organization which represents Margarita Martinez in a case she initiated against police officers and other officials who carried out an illegal raid on her home on November 8, 2009. The letter, cut out in newsprint, stated "Diego, the lives of the Martínez family is in your hands, you will face charges. . . "

The men then told Margarita Martínez to take a taxi to the cemetery "so that you can talk to your dead ones because you will soon meet them" and then to the municipal market. She took a taxi and could see that the three men were following her in a pick-up truck. When the men lost sight of her because of traffic, she got out and ran away.

This is our third letter this year (cf Feb. 11 and Mar. 6) concerning attacks and death threats to Margarita Martínez and her husband, Adolfo Guzman, since the raid on their home in November 2009. Margarita Martínez had a police officer allocated to her on November 24, but when she came out of the café, she could not find the officer. Shortly afterwards, she was threatened by her assailants.

Again we **strongly urge** you to:

- provide Margarita Martínez and her family with effective protection in strict accordance with their wishes:
- carry out a full and impartial investigation into the death threats described above and into previous acts
 of intimidation against Margarita Martínez and her family;
- fulfill your duty to guarantee the safety of all human rights defenders as established by the 1998 UN Declaration on Human Rights Defenders.
